## TUITION FEE CHALLAN – Spring - 2026

1. Semester Fee Invoices pertaining to the Spring - 2026 have been issued on **19<sup>th</sup> Dec 2025**. Download your Fee Invoices from QALAM URL: <https://qalam.nust.edu.pk/> and pay within given due date i.e., **05<sup>th</sup> Jan 2026 (Monday) (without fine) and 20<sup>th</sup> Jan 2026 (Tuesday) (with fine)**.

2. An additional **two weeks after the first due date** will be available to clear outstanding dues **with late fee fine**. After this period, the student shall be **suspended from the semester**. Students are therefore advised to remain fully aware of the academic consequences of delayed or non-payment of dues.

3. Late Fee Fine once levied will not be condoned as per policy, therefore, any request for installments after first due date would be treated accordingly.

4. Students who are unable to pay the full fee in advance due to genuine financial constraints must obtain approval for payment in installments from the **Finance Directorate**, as per the following procedure:

1) **Two (02) Installments via QALAM:** - The application will be submitted by the student on Qalam which will be thoroughly scrutinized by Accounts Officer and forwarded to Principal/Commandant/Dean/ Director for recommendation and subsequently to the Senior Manager (Fee), Main Office NUST (Fee Section). **The last date to apply online for instalments is 01<sup>st</sup> Jan 26 and 15<sup>th</sup> Jan 26 without and with fine respectively.**

2) **Three (03) Installments via Hard Copy:** - The applications would be processed as per previous routine and student will submit / fwd "**Fee Installment Form**" (Revised) through their concerned depts. **The last date to send ION for instalments is 31<sup>st</sup> Dec 25 and 14<sup>th</sup> Jan 26 without and with fine respectively.**

3) **No instalments:** - In the light of NUST Fee Policy, the students who got the facility of instalments in previous semester(s) but did not pay as per schedule, would not be provided this facility again. They have to pay their fee along with arrears for enrolment in Spring-2026 semester.

5. **Payment Instructions:** Students can pay their semester fee through following mode: -

- **1-Link (1-Bill) from any Mobile App / Internet Banking**
- Over the counter through cash at any online **HBL & Askari Bank** branch (make payment latest by **Friday 05<sup>th</sup> Sep 2025**).
- **VERY IMPORTANT NOTE: Direct Fund Transfer to NUST Bank Account is **NOT ALLOWED**.** Fee Section has no responsibility of posting the paid amount to student's Qalam account, in case a student makes the payment of fee through online fund transfer.
